FINDING AID FOR ST MARYS SAFFRON WALDEN CHURCHYARD MEMORIAL STONES - by John Read

Introduction. This memorandum is intended to help locate the present and previous positions of memorial stones in the churchyard. It should be noted that the churchyard was closed to further burials in 1860, and all later burials took place in the Radwinter Road cemetery, for which there is a separate online index. The only exceptions were the burials of R A Butler and his wife, and a few cases shortly after 1860 where there were spaces in existing family burial plots.

A survey of stones in the churchyard was made in 1938 by H Downham and W J Fancett. They divided the churchyard into eight sections and listed the names and years of burial for each legible stone, and how many illegible stones they saw. A notebook containing hand-drawn plans of each section was made at the same time.

An updated survey on the same lines was done in 1950, at the time when it was proposed to clear the churchyard and re-site the majority of the stones along the churchyard walls. Each stone was numbered within its section (superseded by the later numbering system – see below).. By this time, some previously legible stones had become illegible, but also a few more stones were added to the 1938 list.

Between 1978 and 1984, a survey was made by the North West Essex Churchyard Group, and the Essex Society for Family History, after the resiting of the stones along the perimeter walls, and published on microfiche. This time full transcriptions of the stones were made where legible, but a few more had become illegible. 240 stones, including illegibles, were listed, and numbered according to the following pattern:

Nos 1-52 along the south wall of the churchyard backing on to gardens of houses in Church Street (lower section nearest to High Street).

Nos 53-75 along the west wall of the churchyard backing on to the garden of a house in High Street.

Nos 76-135 along the north wall of the churchyard backing on to gardens of houses in Castle Street.

Nos 136-202 along the south wall of the churchyard backing on to gardens of houses in Church Street (upper section opposite south door of church). Nos 203-240 stones (mostly upright tombs) left in situ.

The following lists are copied from the 1938 survey.

Bartlett and Walker missing from the 1950 list. Starling missing from 1984 list. The rest are numbered as follows: Thurgood 165. James Spicer 169. Thomas Spicer 174. Parker 176. Thomas White 177. Priscilla Burrows 178. Robinson 182. Richard Burrows 235 (in situ). Charles White 236 (in situ).

Apart from the two tombs left in situ, the only stones now legible are 176 (Parker) and 177 (Thomas White). The rest, 165, 169, 174, 178, and 182 are now virtually illegible, though their positions can be worked out from the two legible stones. Also on the 1938 plan is a stone named as Mary? 1830. This could be Mary Barns who was the only Mary buried in 1830 per burial register.

The square bracketed items were listed in 1950, but not in 1938. Markham was listed in 1984, but not listed in the two previous surveys. The above are

numbered as follows: Dickson 151, Kidner 179, Laurence Mynott 181, Wm Mynott 183, Markham 234 (flat stone in ground still in situ). Of the above, 151 Dickson, 181 Laurence Mynott, and 183 Wm Mynott are still legible. 179 Kidner and 234 Markham are now virtually illegible.

Dates of burial per burial register are Maria Amelia Mynott 1828, Charles Mynott 1831, Henry? Kidner 1849, Hester Markham 1762.

The square bracketed items were listed in 1950, but not in 1938. The above are numbered in 1984 as follows: George Archer 8, Scott and Rumble 10, Bird 11, Andrews 12, Hodson 13, Nathaniel Catlin 184, Robert Catlin 186, Hannah Archer 237 (in situ), Martin Catlin 238 (in situ), Henry Archer 239 (in situ).

Numbers 237, 238, and 239 are Grade II listed.

The present state of the above stones as follows: 8 George Archer hidden by shrubbery, but appears illegible; 10 Scott and Rumble still legible; 11 Bird illegible; 12 Andrews still legible; 13 Hodson covered in ivy; 184 Nathaniel Catlin hardly legible; 186 Robert Catlin legible. The wordings on the three tombs 237, 238, and 239 still in situ, are badly weathered.

There are also two flat stones still in situ near the path. These are marked on the 1938 plan as being of Nathaniel Catlin and Robert Catlin, and it would seem that the headstones from these were detached and placed by the wall as numbers 184 and 186.

Ann Archer not listed in 1950. Baker, Knowlden and Howlands not listed in 1984.

Surprisingly every one of the above numbered stones is still legible.

Not listed above but listed and numbered in 1984 are Lord Butler 229, and an illegible tomb 230 (both in situ). This illegible tomb is probably that of Knowlden and Howlands, shown in the 1938 plan in a position similar to its present site.

Richard and Elizabeth Ward listed in 1950 but not in 1938. Lesley, Osland, Bailey, Butler, Gibbs, French and Trett listed as illegible in 1950. Munton, Ford, Goodwin, Child and William Turner not listed in 1984. The remainder are numbered as follows: Elizabeth Nockolds 3, Jacob & Elizabeth Nockolds 4, Butler 6, Richard Ward 112, Grigg 113, Barrett 114, Thomas/Mary/Charles Turner 117, Horsnell 118, Elizabeth Turner and Pomfrett 119, Adams 120, Westwood 122, Coulson 123, Bradbury 126, Martin Nockolds 128, Lesley 129, Erswell 202, William Ward 218 (in situ), Joseph Ward 219 (in situ). The present state of the above stones as follows: 3 and 4 Nockolds still legible, 6 Butler covered in ivy, 202 Erswell still legible, 218 (in situ) William Ward no longer legible, 219 (in situ) Joseph Ward still legible. The remainder numbered between 112 and 129 are sited along the north wall adjacent to this section, but they are obscured by undergrowth, and in the shade of trees which cut out the light. The only one now easily legible is 122 Westwood. In addition there are three unnumbered flat stones still in situ in a triangular pattern in the lower part of the section near the path. One of these has a rectangular border with grass in the centre, which looks like the base of an upright tomb. The 1938 plan has a tomb in this position labelled Jacob and Elizabeth Nockolds, whilst the two Nockolds stones numbered 3 and 4 are described in the 1984 survey as being possibly the side panels of a chest tomb. It seems therefore quite likely that the stone in question was the base of the Nockolds tomb from which the two side panels were removed. This is confirmed by notes made about the resiting in 1950, where it is recommended that only the panels should be preserved. There is also another unnumbered flat stone just to the west of the two Ward tombs. The 1938 plan has the tomb of Boughton Munton in this position.

Dates of burial per burial register, Mary Ford 1813, Elizabeth Nockolds 1850, Bailey 1837, Butler 1816, Grigg 1776, French 1767, Esther Horsnell 1837, William Turner 1832?, Susanna Westwood 1854, Osland 1785. Thomas Trett should possibly be Trott.

Thomas and Ann Archer shown on 1938 plan, but not in 1938 list, and not listed in 1950, but recorded in 1984. Jonathan Spicer not listed in 1938 or 1950, but recorded in 1984. Square bracketed entries added in 1950. The following listed as illegible in 1950: Bainbridge, Bell, Filmer, Griffiths, Miller, Barrett, Barham, Green, Mizen, Pratt, Rumbelow, Smith, and Wellby, yet several of these were seen in 1984. The following not listed in 1984: Edwin Butterfield, Sarah Burrows, Filmer, Griffiths, William Leverett ?, Miller, Cornell Spicer, Barrett. Henry Butterfield, Kettle, Mizen, Pratt, Rumbelow, Reynolds?. Numbers 210 and 211 are Grade II listed.

The present state of the above stones as follows: 5 Day legible, 196 John Archer partly legible. The remaining stones are all set against the west or north churchyard walls. Of these the only ones now legible are: 71 Mary Ann Bell, 106 Sarah King, and 107 Richard Ward Spicer. The stones on the west wall, although easily accessible, are weathered, and the following are now virtually illegible: 60 Barham, 61 Newman, 62 Smith, 63 Bailey, 65 Hardwick, 70 Reynolds, 72 Wellby, and 73 Sampson Brown. The stones on the north wall are mostly obscured by ivy growing over the wall, and by dense shrubbery, and the following are now illegible: 79 Cockerill, 80 Simeon King, 85 Robert Browne, 86 Wallis, 88 Grylls, 97 William Leverett (1793), 98 Edward Leverett, 99 Webb, 100 Croft, 130 Sach, 131 Waight, and 133 Bainbridge. Inscriptions on the following tombs left in situ are mainly legible: 210 Edwards, 211 Thomas/Ann Archer, 214 Spicer, 215 John Burdett, 216 Tamar Burdett, 217 Francis Hall. 212 is illegible as listed. There is no sign of 213 William Archer, recorded in 1984 as a flat stone left in situ to the south of 214, and I believe it may have sunk below ground.

Dates of burial per burial register: Isabella Foote Butterfield 1851, Louisa Butterfield 1851, Charles Sach 1851, Mary Pratt 1824, Elizabeth Smith 1834.

In the middle of this section is a cedar tree, which is listed in the 1984 survey with a notice saying it was planted in honour of the coronation of King Edward VII in 1902. The notice has disappeared.

All stones from this section are sited on the west or north walls. The present state is as follows. The stones on the west wall are weathered, and the following are now virtually illegible: 66 Hestler, 67 Anderson, 68 Godfrey, 69 Francis. The stones on the north wall are mostly obscured by ivy or undergrowth, and the following are also virtually illegible: 81 Smart, 82 Low, 83 Cox, 90 Carter, 92 Gray, 93 Parke, 94 Nicholls, 96 Stokes, 104 Spicer/Law, 105 Ward. Of the remainder left in situ, 203 George Fred Good is still legible, but the adjacent 204 John & Sarah Good is covered with ivy. 205 Rider still legible, but 206 Mary Baines and 207 Frye, both flat stones, have disappeared, and have probably sunk below ground as the undergrowth in this area has not been cleared. 208 Tredgett and 209 Emson are still legible. Another unnumbered and illegible stone lies to the north of the Good tombs, and from the 1938 plan must be Clayden. Also a few other unnumbered and illegible flat stones.

Joseph Smith listed as illegible in 1950, but listed in 1984. James Golden added in 1950. Thomas/William/James Allen and Charlotte Latten not listed in 1984. The three Spicers omitted in 1950, but replaced by the names John

and Martha Waite. John and Martha Waite, and also a James Allen listed in 1984, but not the three Spicers.

The following numbered in 1984: Waite 14, Erswell and Webb 16, Mynott 20, James Allen 23, Taylor 27, Smith 28, Bell 30, Darnell 32, Archer 36, Wiseman 37, Golden 41, Unwin 42, Kent 43, White 44, Furlong 45, Brown 47, Parker 193, Winstanley 199. Golden spelt as Golding. All but the last two of these sited against the south wall adjacent to Section VIII. There is also an unnumbered and illegible flat stone in the middle of the grass, partly overgrown, which could well be the missing stone of Charlotte Latten on the evidence of the 1938 plan.

The present state of the above stones is as follows: 14 Waite, 16 Erswell/Webb, 20 Mynott, 23 James Allen, 27 Taylor, 37 Wiseman, 41 Golden/Golding, 193 Parker, all still legible. 45 Furlong part legible. 199 Winstanley legible with difficulty. 28 Smith, 30 Bell, 32 Darnell, 36 Archer, 42 Unwin, 43 Kent, 44 White, and 47 Brown all now virtually illegible.

Date of burial per burial register: Sarah Mynott 1837. Register confirms James Allen Spicer in 1793, John Waite in 1768, Martha Waite in 1780, and Thomas Spicer in 1826. The error seems to be, therefore, tacking the surname Spicer on to John Waite.

These stones were sited along the lower south and west walls, and their present state is as follows: 38 Haselgrove and 39 Robinson difficult to read; 40 Robinson illegible; 49 Cowell/Barrett and 50 Barrett covered with ivy; 51 Bridger illegible; 52 Kiy covered with ivy; (beginning of west wall) 53 Spicer covered with ivy; 54 Charles Adams Chater and 55 Septimus/Elizabeth Chater well preserved and legible; 56 Cohen covered with ivy; 57 Jay/Chater and 58 Arthur Chater well preserved and legible, 59 Jenkins legible.

A note on the 1984 plan says that graves 58 to 64 were removed for the repair of the boundary in 1981 and reinstated in incorrect positions. There is now a gap between 57 and 58, but all seem to be there.
